

# PUMP INSTALLATION CHECKLIST

*Not following all items will void your warranty*

- 1. Force flushing multi-bay wet wing fuel tank systems
- 2. Perform thorough internal inspection of each of the fuel tank bays
- 3. Remove accumulated water and debris
- 4. Check all lines for dry rot or damage
- 5. **DO NOT** use Teflon Tape or sealant of any kind
- 6. **DO NOT** disassemble pump
- 7. **DO NOT** run dry
